The Connectional Lay Organization continue to do a consistent and persistent work in our Lay ministry.

THIRTY THIRD BIENNIAL

The Thirty Third Biennial Session of the Connectional Lay Organization ended on a high note. The convention major focus was on teaching and training led by the Director of Lay Activities, Mrs. Edith Bartley Cartledge assisted by our Young Adult Representative, Mr. John Thomas. The Black Tie Soiree highlighted Wilberforce University and ordained clergy from across the connection delivered soul stirring messages to begin each day's activities. The election of officers for the next four years was held on the first day of the meeting.

It was a blessing having Bishop Sarah Frances Taylor Davis actively participating in morning worship, panel discussion and other activities throughout the convention. Her love for laity was obvious. We appreciate the Bishops and other clergy for attending the Biennial and modeling the bond between laity and clergy.

EXECUTIVE BOARD RETREAT

In November 2013 the Executive Board participated in a Leadership Retreat with Dr. Patricia Larkins Hicks of "Outcomes Management" as the consultant. The Retreat focused on the mission statement of the organization which states; The Lay Organization of the African Methodist Episcopal Church is commissioned to Teach, Train and Empower its members for Lay Ministry, Global Leadership and Service following the Tenets of Jesus Christ.

The two day retreat goal was to bring the very diverse Board to common goals as well as to assist new Board members in being more effective. The feedback from the Retreat was very positive and expressions by all was time well spent.

MAJOR TRAVEL

My travel this year has taken me from coast to coast, to the southern borders of Texas and the heartland of the United States. I along with the Director of Lay Activities, Mrs. Cartledge attended the Global Development Council (GDC) in Lusaka, Zambia. The two of us also attended along with the Young Adult Representative, Ms. Felicia Commodore, the African Development Initiative (LOADI) in Windhoek, Namibia. The Episcopal District Director of Lay Activities from the Ninth Episcopal District also attended the latter. Episcopal Districts 14 - 20 continue to struggle with issues of inclusion, redistricting, and economic concerns. A central focus of each meeting was the 2016 General Conference and election of bishops. Over 25 persons from the African Districts and one from the 16th Episcopal District have announced candidacies.

RECOMMENDATION AND IMPLEMENTATION

I continue to lift up a paragraph from my last report. " In these times as empowered laypersons it behooves us to become involved in the challenges of life around us. We must take bold stands on social issues such as gun control, the poor and increasing poverty, sequestration, cutting assistance for the elderly and other social concerns. We must be willing to take on these tough issues by contacting Congress and State legislators as concerned Christians individually and collectively. I have and continue to encouraged each Episcopal Lay Organization to have a social actions committee and part of each agenda to explore the pertinent social and civic issues not in the best interest of the public in general and faith based people in particular.

It is with sadness and joy we accept the will of God in the untimely tragic death of Sister Eileen Shaw Warner, Third Vice President of the Connectional Lay Organization. While we still mourn her passing we rejoice in the knowledge of being absence from the body is to be present with God. 


Independent Auditor's Report

NOTE A – NATURE OF ACTIVITIES AND SUMMARY OF SIGNIFICANT POLICIES

Nature of Activities

The Connectional Lay Organization (CLO) is a department of the African Methodist Episcopal Church (a nonprofit organization). Its purpose is to organize and train the laity of the African Methodist Church so that each lay person may utilize to the maximum the abilities and skills granted by God, in assisting with the improvement and extension of God's kingdom, and creating happiness, peace, and harmony among its members. The CLO is supported primarily through contributions from the AME Church, biennial convention registration fees, and various other sources of income.

Basis of Accounting

The financial statements of the CLO have been prepared on the accrual basis of accounting and accordingly reflect all significant receivables, payables, and other liabilities.

Basis of Presentation

Financial statement presentation follows the recommendations of the Financial Accounting Standards Board in the Statement of Financial Accounting Standards (SAS) No. 117, *Financial Statements of Not-for-Profit Organizations*. Under SFAS 117, the church is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Property and Equipment

Acquisitions of property and equipment in excess of \$500 are capitalized. Property and equipment are carried at cost or, if donated, at the approximate fair value at the date of donation. Depreciation is computed using primarily the straight-line method.

Revenue Recognition

Contributions received are recorded as increases in unrestricted, temporarily restricted, or permanently restricted net assets, depending on the existence and/or nature of any donor restrictions.

All donor-restricted contributions are reported as increases in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

Contributed Services

The CLO receives various amounts of services donated by its members in carrying out the CLO's ministry. No amounts have been reflected in the financial statements for those services since they do not meet the criteria for recognition under SFAS No. 116, *Accounting for Contributions Received and Contributions Made*.

Income Taxes

The AME Church, including all of its components, is exempt from federal and state income taxes under Internal Revenue Code Section 501 ©(3).

Cash and Cash Equivalents

Cash and cash equivalents include all monies in banks and highly liquid investments with maturity dates of less than three months. The carrying value of cash and cash equivalents approximates fair value because of the short maturities of those financial instruments.

NOTE B – CASH

The total cash held by the CLO at March 31, 2014 was \$318,051. All of the monies invested by the CLO were insured provided by the federal government.

NOTE C – RESTRICTED NET ASSETS

Temporarily restricted net assets were comprised of \$9,568 held on behalf of the AME V-Alert.

NOTE D – CONCENTRATIONS

The CLO receives greater than 30% of its annual operational revenues from the Connectional Church of the AME.

NOTE E – RELATED PARTY

The CLO is a department of the African Methodist Episcopal Church. Each year the CLO is allocated \$194,964 by the African Methodist Episcopal Church.
